## **AWE-INSPIRING JOURNEY**

Pyramids rise above sun-baked sands. The Sphinx stares, unblinking, into a relentlessly blue sky. Boats wend their way down the waters of the Nile. Traders hawk their wares in the dusty bazaars. In many ways, Egypt seems timeless, unchanging. However, modern politics are very present in this ancient land and our specialists continue to visit Egypt to gauge the atmosphere and levels of service available throughout the country. It remains a friendly and hospitable place, exploring this dynamic destination. [A cruise down the Nile](#) is still one of the most effective ways to see Egypt, including the archaeological treasures around Aswan and Luxor. But there is more to see on an Egypt vacation than the ancient sites – coral reefs in the clear waters of the Red Sea, afternoon tea at the Victorian-era Old Cataract Hotel, medieval sites in the souqs of Cairo.

The Kingdom of Jordan is a constitutional monarchy under the rule of King Abdullah II. He serves as the chief executive and the commander-in-chief of Jordan's armed forces. The king also appoints all 60 members of one of the two houses of Parliament, the *Majlis al-Aayan* or "Assembly of Notables." The other house of Parliament, the *Majlis al-Nuwaab* or "Chamber of Deputies," has 120 members who are directly elected by the people. Jordan has a multi-party system, although the majority of politicians run as independents. By law, political parties can not be based on religion. Jordan's court system is independent of the king, and includes a supreme court called the "Court of Cassation," as well as several Courts of Appeal. The lower courts are divided by the types of cases they hear into civil and sharia courts. Civil courts decide criminal matters as well as some types of civil cases, including those that involve parties from different religions. Sharia courts have jurisdiction over Muslim citizens only and hear cases involving marriage, divorce, inheritance, and charitable giving

## **Itinerary**

### **Day 1. Home Town – Cairo**

Today your amazing Egypt tour begins. You will board the outbound flight to Cairo. Enjoy the onboard food, beverage and the entertainment.

### **Day 2. Arrive Cairo**

Upon clearing Customs and Immigration, you will meet your local tour guide. Then will be transferred to our resort hotel. You will have free time to rest, relax and acclimate to your new time zone.

### **Day 3. Cairo (Breakfast, Lunch)**

Have your breakfast at the hotel. Your private Egyptologist tour guide and driver will pick you up to start your day tour. Drive to Sakkara to see the Step Pyramid, built for the 3rd Dynasty Pharaoh Djoser by the exalted architect Imhotep. You will experience visiting one of the mastabas in Sakkara that dates back to more than 4500 years ago and see the amazing carvings and colors which gives an idea about how was life in ancient Egypt. You will end your time in Sakkara in a carpet school where you will be involved in an experience including locals who are being trained for an amazing handcraft of weaving following their ancestors who started it thousands of years ago. Have lunch at a restaurant. Continue to Giza to visit one of the Ancient Seven Wonders of the World, the Great Pyramids. See the Valley Temple, and the Sphinx. (Optional: Possibility to have extra fun and enjoy a camel ride through the desert around the Pyramids, pay on site). On your way, you will visit a papyrus institute. Return to your hotel for overnight.

### **Day 4. Cairo (Breakfast)**

Today is free on your own to explore the City. Or join an optional tour to Alexandria with lunch - \$140/person Early morning departure to Alexandria, arrival and start your visit with the Catacombs, Greek site. The catacombs of Kom El Shoqafa is a historical archaeological site located in Alexandria, Egypt, and is considered one of the Seven Wonders of the Middle Ages. Continue to the Library of Alexandria for a scheduled tour. After the visit, lunch and enjoy a quick ride by the Cornish, visit Quaytbey Fort from outside and taking pictures from outside. Late afternoon, drive back to Cairo. On the way stop and enjoy tasting the pie of all pies (the Egyptian origin of pies and pizzas in the whole world). Then having tea or coffee and continue driving back to your hotel

### **Day 5. Cairo - Aswan - Nile River Cruise (Breakfast, Dinner)**

After breakfast, you will be transferred to Cairo airport for your flight to Aswan. Upon arrival in Aswan, our representative will transfer you to your Nile cruise. Take a tour of Aswan High Dam, Egypt's contemporary example of building on a monumental scale. Continue by a short motorboat ride to the Temple of Philae on the island of Agilka. The temple was dedicated to Isis, sister/wife of Osiris and patroness of the Ptolemaic rule. Return to your cruise and sail to Kom Ombo.

### **Day 6. Nile River Cruise (Breakfast, Lunch, Dinner)**

Visit the Temple of Sobek, the crocodile-headed god of fertility and creator of the world. The temple stands at a bend in the Nile where, in ancient times, sacred crocodiles basked in the sun on the riverbank. Sail to Edfu. Continue sailing to Luxor and overnight.

### **Day 7. Nile River Cruise (Breakfast, Lunch, Dinner)**

After breakfast onboard, cross to the West Bank of the Nile and visit the wondrous Valley of the Kings, a vast city of the dead where the magnificent tombs of 62 pharaohs have been discovered. The tombs were carved deep into the desert rock, richly decorated and filled with treasures for the afterlife of the pharaohs. Visit several of the tombs. Next, visit the Temple of

**Queen Hatshepsut. This beautiful monument to the reign of the only female pharaoh rises out of the desert plain in a series of terraces and merges with the sheer limestone cliffs that surround it.**

**On the way back to your Nile Cruise, stop at the famed Colossi of Memnon, two 66ft, 1 thousand tons statues of Amenhotep II. Return to your Nile Cruise.**

**Day 8. Nile River Cruise - Luxor - Cairo (Breakfast)**

**After breakfast, disembark from the Nile Cruise and visit Karnak Temple, called by some “the Temple of Temples.” It is the largest place of worship ever built. Within the complex, the great “Hypostyle Hall” is an incredible forest of giant pillars covering an area larger than the whole of Notre Dame Cathedral. Then visit the Temple of Luxor built by Amenhotep III and Ramses II for ritual and festivals and dedicated to the god Amun. Transfer to the airport for your flight back to Cairo. Upon arrival to Cairo airport, you will meet our representative and will be transferred to your hotel.**

**Day 9. Cairo, Egypt - Amman, Jordan (Breakfast)**

**After breakfast, transfer to Cairo airport for a flight to Amman, Jordan. (Flight is included) Welcome to Jordan! Upon arrival at Amman International Airport, you will be met by our representative in Jordan and transferred to your hotel in Petra. Petra is a famous archaeological site in Jordan's southwestern desert. Dating to around 300 B.C., it was the capital of the Nabatean Kingdom.**

**Day 10. Petra - Dead Sea (B)**

**After breakfast, your tour starts in Petra to visit the biggest attraction in Jordan, also a UNESCO World Heritage Site. Petra was first established in around 6th century B.C by the Nabateans, a nomadic tribe who settled in the area and laid the foundations of a commercial empire that extended up to Syria. The visit starts at the visitors center, where each person is assigned a Bedouin guided horse for the journey to the entrance of the lost city. After passing some tombs which are located outside the city, the visitor passes through the SIQ, The SIQ is the main entrance to the ancient Nabatean city of Petra in southern Jordan. Also known as Siqit, it is a dim, narrow gorge and winds its way approximately 1.2 kilometers and ends at Petra's most elaborate ruin, Al Khazneh. After the amazing Petra visit, transfer to Dead Sea.**

**Day 11. Dead Sea - Madaba - Dead Sea (B)**

**Today's tour will begin with a morning visit in Madaba then head to Mt. Nebo. Madaba is an ancient town in Jordan, southwest of the capital Amman. It's known for its 6th-century mosaic map of the Holy Land in the Greek Orthodox Church of St. George. Mount Nebo is mentioned in the Bible as the place where Moses was granted a view of the Promised Land before his death. Afternoon, we will drive towards the Dead Sea, feel free to experience floating in the Dead Sea, a lake known for one of the saltiest formations of water in the world.**

**Day 12. Amman - USA (B)**

**After breakfast, transfer to Amman Queen Alia International Airport (AMM) and tour guide will assist with check-in for your flight back home. Say goodbye to the amazing country. Home sweet**
