June 10, 2026. Arrive Bali (In-flight Meals, Dinner)

Upon clearing Customs and Immigration, you will meet your local tour guide. Your guide will present you wit a welcome packet including all necessary documentation and vouchers and all contact information of your guide and local offices. June 11, 2026. Bali Kuta (Breakfast, Special Welcome Dinner)

This morning you will enjoy breakfast at the hotel and will have some leisure time to relax. Then, experience an evening of Kechak Dance at a cliff top temple followed by a barbeque, seafood dinner under the stars. In the late afternoon you will be taken to the location of the famous cliff hanging temple at Uluwatu. Perched on the edge of a steep cliff, the temple sits 70 meters above the crashing waves of the Indian Ocean. The temple is inhabited by a large number of monkeys, many of whom can be found roaming the pathways. As the sun sets over the glittering ocean, watch a dramatic Kechak Dance or Ramayana Monkey Chant performance at the temple. Wearing traditional checked cloth around their waists, the male dancers chant in unison while depicting a battle from the Ramayana. After the performance drive to one of the beautiful beaches in Jimbaran for a barbeque seafood dinner in a beach restaurant. Feast on a succulent seafood platter including prawns, grilled fish, squid and clams. Try some 'kangkung', also known as Indonesian water spinach, and add some heat in the form of sambal, the spicy Indonesian sauce.

<u>June 12, 2026</u>. Bali Kuta- Ubud (Breakfast, Dinner) Today after enjoying breakfast, we will drive to Ubud (about 1 hour). On the way to Ubud, We will visit the Coffee Factory to have a coffee break and visit UC Silver store. Ubud still reflects the unique Balinese way of life as well as emanating a whole lot of charm and a low-key vibe that is irresistible. A trip to ATV riding and afterward it is shopping time. Dinner included.

June 13, 2026. Ubud (Breakfast, Lunch)

Today spend a full day discovering the natural beauty and ancient relics of the Balinese midlands. Meet your guide and driver and then start the day with a visit to Pura Taman Ayun, the 17th century temple of Mengwi, set in a beautiful park with trees and ponds full of lotus blossoms. What languages are spoken in Indonesia?

Indonesian, or Bahasa Indonesia, is the official language of Indonesia, but there are over 700 indigenous languages in use, and these can differ greatly from island to island. Although English is widely spoken in popular destinations such as Yogyakarta and Bali, a good phrasebook can help in many situations, especially if you're planning to travel to lesser-visited islands and your phone runs out of charge or coverage.

What food and drink should I try in Indonesia?

In Indonesia, you should try popular dishes like satay (skewered meat with a peanut sauce), and nasi goreng (Indonesia fried rice). Also look out for beef rendang (a mild curry), gado gado (a vegetable salad), sayer asam (sour soup), siomay (steamed fish dumplings), and rawon (a hearty beef stew). In general, the food in Indonesia is fresh and spicy and includes lots of options for vegetarians.

You'll also find lots of traditional herbal teas for sale in Indonesia, often made with a warming blend of ginger, cardamon, lemongrass, or lime leaves. Wedang jahe (ginger tea), bajigur (coffee with coconut milk, pandan leaves, and ginger), and jamu (a turmeric, lemon, and ginger infusion) are all popular but ask for local recommendations when you arrive.

What's the currency of Indonesia?

The currency of Indonesia is the Indonesian rupiah (IDR). You'll find ATMs in all major cities and visitor destinations, and hotels and larger shops and restaurants accept credit cards. However, cash is still the predominant form of payment in mos shops, markets, and at smaller food venues.

How much should I tip in Indonesia?

You can tip around 10% at restaurants in Indonesia. Most upmarket restaurants, bars, hotels, and lodges will include a 10% service charge on your total, while at local restaurants leaving 10% is considered generous. Taxi fares also include a 10% service fee, but drivers and guides, especially those who accompany you for several days, should be tipped extra. Tipping on cruises is also encouraged but will vary by boat and crew size.

How long does it take to fly to Indonesia from the US?

It takes around 20 to 25 hours to fly to Indonesia from the East Coast of the USA, and around 23 to 27 hours from the West Coast.

What's the time zone in Indonesia?

Indonesia covers three time zones ranging from UTC+7 in the west of the country to UTC+9 in the east. Indonesia does not observe Daylight Savings Time.

What's the best way of getting around in Indonesia?

With about 6,000 inhabited islands, getting around Indonesia involves plane or boat travel, as well as taking private transfers. Regular flights run between all the major islands, and ferries operate between islands that are grouped together, making it easy to travel by boat on an island-hopping trip from Java through Bali and on to Lombok and the Komodo Islands, for example.

Do I need vaccinations to visit Indonesia?

Your doctor can provide you with immunization advice for Indonesia, but you should also ensure you're up to date with the recommended vaccinations for your home country. You can also check the recommended vaccinations by visiting the <u>Centers for Disease Control and Prevention website</u>.

What do I need to check with my passport for travel to Indonesia?

Check that your passport has two blank pages and will be valid for a minimum of six months beyond your arrival date in Indonesia.
